Job Purpose

Sightsavers is going through a digital transformation in utilising data for key decision making. The organisation is rolling out data analytics through the provision of Power BI reports to all key data users, as a central tenant of promoting a data driven culture. Data analytics is increasingly supporting the management, development and monitoring of programmes and projects throughout Sightsavers Portfolio and integrating the Microsoft Power Platform into our processes is the next step in this.

The role will work within the Data Analytics and Reporting Team to produce and maintain a suite of Power BI reports. As this is done the role holder will provide training and support for staff across the organisation to support the adoption of data visualisation software into their normal working practices.

To ensure that Power BI provides the best quality data analytics and highest possible data quality the Data Visualisation Officer (DVO) will provide capacity building work with country offices through the data management assistance process. Using this process to entrench a strong data culture with visual analytics at its heart.

It is anticipated the position will involve some international travel of up to 8 weeks per year, if/when non-urgent international travel becomes feasible again.

Main Responsibilities

Development of Power BI reports

- Scoping key stakeholder data visualisation needs to ensure Power BI reports provide data driven solutions to their work needs, with an initial focus on our in-country project staff.
 - Create Power BI reports for a wide range of organisational user groups with a focus on providing a strong, data focused, user experience.

- Ensure all Power BI reports meet the accessibility requirements of their audience.
- Ensure all Power BI reports are compliant with information security guidelines.
- Support the Data Analytics and Reporting Manager (DARM) and Quality Assurance Manager (QAM) to create dataflows and certify data sets for organisational consumption.

Maintenance of Power BI reports

- Update Power BI reports to include new software functionality, as updates are released onto the platform.
- Work with other teams to update Power BI reports to include new data sets and visualisations.
- Evaluating the ongoing use and relevance of the Power BI reports to Sightsavers staff's work and adapting the reports to maximize engagement and effectiveness.
- Integrating other elements of the Power Platform, primarily PowerApps, to streamline data entry and analysis.

Capacity building and training of Sightsavers staff on Power BI and data analytics

- Train Sightsavers staff, principally in our country offices, on the use and development of Power BI reports.
- Provide ongoing support to all staff on how to use and develop Power BI reports after training.
- Provide ad hoc Power BI support to all Sightsavers staff.
- Support the DARM and QAM in developing a data driven culture throughout the organisation

Country office data management assistance

- Work with country offices to map project data flows.
- Strengthen country office data reporting systems through the development of tools to collect and collate data to the highest possible standard.
- Support country office staff to build the capacity of partners in data quality assurance.

The principal accountabilities are not meant to be an exhaustive list of tasks. The need for a high degree of flexibility is required and the job holder is expected to carry out any other duties that may be required to assist the wider team if within the employee's skills and abilities, whenever reasonably instructed.

- Understanding of international development issues and a commitment to equality of opportunity for people with disabilities.

- Master's degree in international development, international relations, geography, statistics, or appropriate equivalent.
- Relevant overseas experience i.e. either professional or voluntary work.

- Proficient in the use of Power BI, Tableau or other data visualisation software.
 - Demonstrated ability to communicate information, practices, and ideas to a non-technical

- Comfortable with manipulating quantitative and qualitative data sets.
- Good analytical skills with the ability to identify important issues and communicate these effectively to colleagues.
- Able to work with multiple stakeholders and ensure differing concerns and priorities are effectively managed.
- Proficient in using the Microsoft Office suite, particularly Excel to an advanced level e.g. advanced formulas such as VLOOKUP and pivot tables.
- Demonstrated ability to effectively prioritise work in a busy environment with competing deadlines.

- Experience of digital transformation, implementing new software/tools/working practices within an organisation.
- Experience working with MS PowerApps or MS Power Automate
- Experience of using Power Query for extraction, transformation, loading and connecting data from different data sources.
- French and/or Portuguese language skills
